

## TERMS AND CONDITIONS OF PARTICIPATION

### **Contest Theme**

The art contest titled "My Dream Biscuit" is open to children aged up to 15 years. Its purpose is to encourage creativity and imagination.

Through drawing or painting, children are invited to depict their "dream biscuit"—a unique biscuit character or hero placed in a fantasy world inspired by their values, thoughts, and emotions.

They are also encouraged to communicate a **positive message or feeling** through their artwork, such as friendship, love, hope, peace, environmental protection, or care for others.

The contest offers children a **creative outlet for free artistic expression**, linking the joy of their favourite snack with meaningful ideas that raise awareness—such as peace, poverty, hunger, the environment, animals, and empathy.

# Eligibility

• Open to children aged 15 years and under, who are permanent residents of Cyprus.

#### Age Categories

- Under 8 years old
- 8 to 11 years old
- 12 to 15 years old

Submission Period: 2 October 2025 – 19 December 2025

Evaluation of Entries: January 2026

Announcement of Winners: January 2026

### **Submission Guidelines**

• Paper size: Preferably A3 or tabloid size, A4 also accepted.

• Mediums: Any (coloured pencils, markers, watercolours, crayons, etc.).

- Presentation requirements:
  - 1. No thick materials or frames allowed.
  - 2. Maximum thickness of artwork: 5mm.

## Non-Accepted Entries

- Collaborative works (entries must be individual).
- Works not created by the participant.
- Entries without a fully completed and signed **Participation Form**.
- Artworks containing:
  - o Commercial characters or logos (e.g. superheroes).
  - o Photographs or scanned images of other works.
  - Offensive or inappropriate content.

## Participation Form & Parental Consent

- Each entry must include a fully completed Participation Form.
- The form can be downloaded from <u>www.froufrou.com.cy</u> or collected from the company's Head Office in Kokkinotrimithia.
- The completed form must be securely attached to the back of the artwork.
- Parental or guardian consent is mandatory.
- Where both parents share custody, both must sign. If only one parent has custody, that parent's signature is sufficient. If neither parent is available, the legal guardian must sign.

## Rules of Participation

- No purchase or entry fee is required.
- The entry must be the original work of the participant.
- Participants must fall within one of the specified age categories.
- Works that have been published, submitted to other contests, or infringe third-party rights will not be accepted.
- Only physical artworks will be accepted (digital submissions are not allowed).
- Paper size must be **400mm x 550mm or smaller**. Recommended sizes: A3 or tabloid. A4, quarter and octavo formats are also acceptable.
- No restriction on colour, medium, or paper shape. However, artworks exceeding 5mm in thickness will be disqualified.
- Submitted artworks will not be returned.
- Each entry must be accompanied by the completed Participation Form, including the following details:
  - 1. Age category
  - 2. Title of artwork
  - 3. Description of the participant's "dream biscuit" concept
  - 4. Participant's full name
  - 5. Age and date of birth
  - 6. Gender
  - 7. Parent/guardian name(s)
  - 8. Postal address
  - 9. Contact telephone number

- 10. Email address (if available)
- 11. Signatures of the participant and parent(s)/guardian(s)
- When both parents share custody, both must sign. If only one parent has custody, one signature is sufficient. If neither parent can sign, the legal guardian must sign.
- By submitting an entry, the participant and their parent(s)/guardian(s) accept these terms
  and conditions and agree not to dispute the decisions of the judging panels appointed by
  ALKIS H. HADJIKYRIACOS (FROU FROU BISCUITS) PUBLIC LTD.
- Any personal data collected will only be used for contest-related purposes.

## Intellectual Property & Usage Rights

- Submitted artworks may be used in advertisements, printed materials, and promotional campaigns by the organiser and approved partner companies.
- Children of company employees and partners are also eligible to participate.

### Deadline for Submission

All entries must be received no later than Friday, 19 December 2025.

# Judging & Evaluation

- Only entries meeting all requirements will be eligible for evaluation in the nationwide contest in January 2026.
- The **top 3 entries** in each age category (9 winners in total) will receive prizes.
- Entries will be judged by internal committees and external experts appointed by the organiser, based on originality, creativity, and the message conveyed.
- All decisions of the judging panel are final.

- Winners will be announced in January 2026.
